1. COMPLETE APPLICATION FORM IN FULL

2. SUPPORTING DOCUMENTATION

In support of the Application you should attach copies of the following:

1. **Valid** Tax Clearance Certificate
 2. **Proof** of Public Liability Insurance
 3. **Letter** of good standing from your Bank
 4. **For Contractors:** Recommendation letter from Major Supplier where you buy your products or materials from
 5. **For Contractors:** Three (3) reference letters from three of your clients commending on the Quality of your Service and Workmanship
 6. **For Manufacturer / Supplier:** Three (3) reference letter from three of your clients commending on the Quality of your Material / Products
 7. **Proof of Payment** for Entrance Fee/Admin Fee (R 1 500)
 8. **Application Form** Completed and Signed

Application checked by Administrator. Approved for submission on fully completed application form and valid supporting documents. Administrator submits to committee.

6. COMMITTEE DECISION

Office Bearers / Committee Members evaluate Compliancy Criteria.

7. OUTCOME

Application Approved / Rejected.

8. APPROVAL LETTER

Applicant will be notified by an Approval letter from the Chairman of the Waterproofing Association of Gauteng.

9. INVOICE

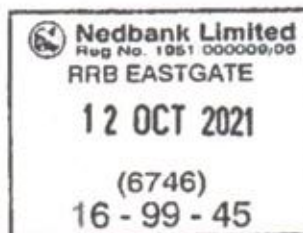
New Members (Approved) will be invoiced for yearly membership fee on a pro-rata basis according to the association's financial year. (FY July to June).
